

Celebrity Reflection Daily Win Game Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility:

Celebrity Reflection Daily Win Game (the "Sweepstakes") is open only to legal residents of the 50 United States and the District of Columbia who are at least 21 years old at the time of entry. To receive a Grand Prize, entrant must be able to submit a valid IRS Form W-9. Employees of Celebrity Cruises, Inc. ("Sponsor"), Merkle Inc. ("Prize Administrator"), Toy Fight Limited, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

Agreement to Official Rules; Entrants Will Be Disqualified for Violations:

Participation constitutes each entrant's full and unconditional agreement to these official rules ("Official Rules"). The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited. Sponsor's, and where applicable Prize Administrator's, decisions are final and binding in all matters related to the Sweepstakes. In the event there is a discrepancy or inconsistency between any statements contained in any Sweepstakes-related materials (including printed versions of these Official Rules) and these Official Rules, these Official Rules shall prevail, govern and control.

Sponsor may, in its sole discretion, disqualify any entrant who engages in such conduct and void all associated entries. Any attempt to deliberately undermine the Sweepstakes may violate criminal and civil law, and Sponsor reserves the right to seek damages to the fullest extent permitted by law. Sponsor's failure to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

Sponsor/Prize Administrator:

Timing:

The Sweepstakes begins on July 23, 2026 at 12:01 a.m. Eastern Time ("ET") and ends on November 11, 2026 at 11:59 p.m. ET (the "Promotion Period"). This Sweepstakes includes 112 "Daily Entry Period" drawings, 1 for each "Day" of the Sweepstakes. A Day is defined as starting at 12:01 a.m. ET and ending on the following day at 12:00 am ET (except for the final day which ends at 11:59 pm ET). The Sweepstakes also includes a Grand Prize drawing, which spans the entire Promotion Period. Sponsor's servers are the official time-keeping devices for the Sweepstakes.

How to Receive Entries:

Method 1 -Daily Visit to the Promotion Site:

During the Promotion Period, visit the [Promotion Site](#). You will be invited to play an entertainment-only game. You are not obligated to play. To skip the game, hit the ready to play and wait for up to 3 minutes for the game to conclude. After you play or wait for the game to conclude, you will be prompted to accurately provide your full name and valid email address to claim 1 entry into Daily Entry Period drawing associated with the date and time of this action and 1 entry into the Grand Prize drawing. To earn additional entries, you may return to the Promotion Site each Day and repeat the above process to receive an additional Daily Entry Period entry and a Grand Prize entry.

Method 2 – Bonus Entries for Completed Referrals of this Sweepstakes

You will be invited to refer persons who:

- meet the eligibility requirements;
- are individuals with whom you have a personal relationship, and

Click on the share button and follow the instructions to share a personalized unique link. For each Friend who clicks on your shared content (which includes a personalized unique link), visits the Promotion Site, and participates to claim at least 1 entry during the Promotion Period, you will receive 1 additional entry into both the applicable Daily Entry Period drawing associated with the date and time of the Friends participation and the Grand Prize Drawing.

Entry Limitations:

Multiple entrants are not permitted to share the same email address. In the event of a dispute as to the identity of an entrant, Sponsor will rely on the information submitted by the entrant to participate in this Sweepstakes. If any additional information provided by entrant is inconsistent with the information provided for this Sweepstakes, the Sponsor and/or Prize Administrator may disqualify such entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

Prize Drawings and Winner Requirements:

Sponsor's decisions as to the selection of the potential winners are final and binding.

Daily Entry Period Drawings: There are a total of 206 Daily Entry Period Prizes, consisting of 6 different Celebrity branded gifts (quantities and descriptions listed below in the Prize section) that will be awarded to the Daily Entry Period winners. From July 23, 2026 through August 9, 2026, Sponsor will randomly select 1 potential winner from all eligible entries received during each Daily Entry Period. For the remainder of the Promotion Period, Sponsor will randomly select 2 potential winners from all entries received for each applicable Daily Entry Period. See the Appendix for the list of prizes offered for each Daily Entry Period drawing. If you have been selected to win a Daily Prize you will receive an email from Sponsor. Within about 1 week, you will receive an additional email notification from Prize Administrator with instructions on how to claim the prize. Potential Daily entry Period winners must confirm their eligibility and provide their full home mailing address (P.O. Boxes are not permitted) within 3 days of the date notice or attempted notice is sent from Prize Administrator to claim their prize. Failure to timely respond will result in forfeiture of the prize.

Grand Prize Drawing: Sponsor will randomly select the potential Grand Prize winners on or around November 13, 2026. Prize Administrator will notify potential winners by email shortly thereafter. Each potential winner will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") and an IRS Form W-9 which must be received by Prize Administrator within 5 days of the date notice or attempted notice is sent, in order to claim the prize.

For All Winners: If a potential winner cannot be contacted, fails to sign and return the Declaration, the IRS Form W-9 (applicable only to Grand Prize winners) or provide any other requested information within the required time period, or the prize is returned as undeliverable, the potential winner forfeits the prize. Winner will not receive difference between actual and approximate retail value. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason.

Total ARV:

The total ARV of all available prizes offered in the Sweepstakes is \$53,774.22

Odds of Winning:

Where applicable, prize style, size and all other details will be determined by Sponsor in its sole discretion.
